SPONSORED FUEL AGREEMENT- FIELD DEMONSTRATION EQUIPMENT

GROWMARK, Inc. will supply all of the power fuel used for field demonstration purposes at this year's Farm Progress Show.

Fuel will be supplied to the field demonstration equipment as follows:

- Fuel will be dispensed from the fueling location established on the Farm Progress Show site designated by FS flags.
• Fuel available at the on-site location will be gasoline and off road biodiesel.
• Equipment used in the field demonstrations during the Farm Progress Show event will receive up to 50 gallons of sponsored fuel per vehicle (gas or diesel) at no charge in exchange for displaying FS promotional signs on each vehicle throughout the show.
• Sponsored fuel must be received by 5:00 pm on August 26 and the promotional signs left in place on the vehicle until closing time on the third day of the show.
• After receiving the 50-gallon maximum of Sponsored Fuel, additional fuel can be purchased and will be billed to the company that owns the equipment. This fuel will be billed at Evergreen FS, Inc regular tank wagon price for delivered fuel. Fuel delivered to equipment off the show site will not qualify for the 50 gallons of free fuel.
• Fueling operations for sponsored fuel will begin on the afternoon of August 21 and conclude at 10:00 a.m. on August 30. Hours of operation are 8:00 a.m. – 5:00 p.m.
• There will be no cash transactions for fuel deliveries made to Farm Progress Show participants.

All Sponsored Fuel will come from the flagged on-site fueling station.
