

2019 Illinois Farm Progress Show
On-site Fuel Deliveries to Exhibitors/Show Vendors

Evergreen FS, Inc. (402 N. Hersey Rd., Bloomington, IL 61702) will supply all of the Exhibitors/Show Vendors power fuel needs inside the Progress City grid.

All exhibitors and vendors who require fuel delivered on-site for generators and refrigerated trailers are to work directly through Evergreen FS to establish customer accounts, credit and to schedule delivery of fuel.

Evergreen FS Inc. is providing vendors (with approved credit) access to a 24/7 self-service fueling station for all motorized vehicles requiring gasoline or off- road diesel from July 1, 2019 until October 31, 2019. Said fueling station will be located at the Northeast entrance by the loading/unloading docks. Please contact Evergreen FS five business days in advance of your arrival to the show for key fob instructions and credit approval. Contact information regarding fuel purchases and credit is listed below.

Fuel delivered to the show site for exhibitors/vendors regarding generators will be charged at tank wagon prices plus an on-site delivery fee of \$35.00.

- Customer accounts are to be set-up with Evergreen FS at least 2 weeks in advance of when fuel will be needed.
- Evergreen FS will run credit checks on each new account and will establish each customer's payment terms.
- Exhibitors/vendors are to furnish Evergreen FS with a map of their location on the Farm Progress Show site that clearly shows the fuel tank(s) or staging area for vehicles, and the name and phone number of the on-site contact for fuel deliveries.
- Fuel will only be delivered to approved fuel storage tanks provided by the exhibitor/vendor or directly into generators. If the location or type of fuel storage tank does not meet code, Evergreen FS will not deliver fuel.
- Exhibitors/vendors are to contact Evergreen FS 1 day in advance to schedule fuel deliveries on-site at the Farm Progress Show. For same-day fuel delivery requests, Evergreen FS reserves the right to charge an additional fee for rush delivery.
- On show days, fuel deliveries to exhibitor generator locations inside the Progress City grid, will only be made after the show closes. Be sure to be on the evening generator fill schedule. **No deliveries are allowed during show hours.**
- Exhibitor/vendor is to provide fuel delivery staff with clear access to fuel tank(s). If privacy fences or other items block access to the tank(s), it is the exhibitor/vendor's responsibility to provide access at the time the fuel delivery is made. If access is not provided, Evergreen FS is not obligated to deliver fuel and will have the option of charging the exhibitor a service fee. It will be the responsibility of the exhibitor/vendor to contact Evergreen FS to reschedule the fuel delivery.
- If the exhibitor/vendor has motorized vehicles, efforts should be made to have an account set up to utilize the 24/7 self-fueling station located directly outside of Northeast gate by loading/unloading dock.
- Bulk truck fueling operations for generators will begin on the afternoon of August 17 and conclude at the end of the show on August 30. Hours of operation are 8:00 a.m. – 5:00 PM. Scheduled generators will be filled every evening after show or as frequency requires.

There will be no cash transactions for fuel deliveries made to Farm Progress Show participants.
