SPONSORED FUEL & ADDITIONAL FUEL PURCHASE AGREEMENT FOR IN-FIELD DEMONSTRATIONS

GROWMARK, Inc. agrees to supply power fuel (Sponsored Fuel) to Participating Companies who demonstrate tractor, implement and harvester capabilities during Field Demonstrations at the 2023 Farm Progress Show. Participating Companies are eligible to receive Sponsored Fuel under the terms and conditions outlined below, and may also open accounts to Purchase Additional Fuel.

SPONSORED FUEL QUALIFICATIONS & TERMS

- Each tractor or harvester that operates during the in-field harvest and tillage demonstrations during the 3-day Farm Progress Show will receive up to 50 gallons of fuel at no charge. In exchange for any amount of Sponsored Fuel dispensed, the Participating Company agrees to display FS promotional signs on each vehicle receiving said fuel, until the show closes on Thursday August 31.
- Equipment used in the field tile demonstrations during the 3-day Farm Progress Show will receive up to 25 gallons of Sponsored Fuel, per vehicle at no charge. Only tractors operating tool bars or PTOs are eligible to receive free fuel. In exchange for any amount of Sponsored Fuel dispensed, a Participating Company agrees to display FS promotional signs on each tractor receiving fuel, until the show closes on Thursday August 31.
- All Sponsored Fuel will be dispensed directly from the stationary, Designated Fueling Location established on the Farm Progress Show site. Field Demonstration Drivers can visually identify the location of the Location by flags displaying the FS brand.
- Sponsored Fuel, available at the Designated Fueling Location, will be gasoline and off-road biodiesel.
- Sponsored Fuel will not be delivered to equipment staged off the Farm Progress site. Field Demonstration Drivers are expected to bring equipment to the Designated Fueling Location to receive Sponsored Fuel.
- Sponsored Fuel allocated for in-field demonstrations must be received before 5:00 pm on Monday August 28.
- Sponsored Fuel allocation of 50 gallons/vehicle or 25 gallons/tractor will be adjusted downward, at the discretion of GROWMARK Inc and Farm Progress Show management, should field demonstrations be delayed or cancelled due to weather interferences.

TERMS TO PURCHASE FUEL AFTER RECEIPT OF SPONSORED FUEL

- After receiving the 50-gallon or 25-gallon maximum of Sponsored Fuel, Participating Company may purchase Additional Fuel to continue field demonstrations. Drivers will receive fuel at the Designated Fueling Location.
- Participating Company will establish an account with GROWMARK, Inc. by August 7, 2023.
- GROWMARK, Inc. will run credit checks to establish new accounts.
- Additional Purchased Fuel will be billed to the Participating Company and will only be dispensed into their owned engines.
- Additional Fuel purchases will be billed at current tank wagon price via invoice by GROWMARK, Inc. for total volume purchased by the Participating Company for their Farm Progress Show operations. Invoices will be emailed to your Purchasing Agent named below
- No cash or credit card transactions for fuel receipt will be made during the Farm Progress Show.

DESIGNATED FUEL LOCATION HOURS OF OPERATION

- The Designated Fuel Location will operate from August 24 – August 31 from 8:00 a.m. – 5:00 p.m. The Designated Fueling Location will close at 12:00 PM September 1.
- Designated Fueling Location will close daily for brief periods, and notice will be posted at the site.

BULK FUEL AGREEMENT & TANK WAGON DELIVERY

- Companies who require Bulk Fuel Delivery to their Exhibit Lot inside the fenced Farm Progress Show grid, or to tanks staged off the Farm Progress Show site must sign a separate agreement with Evergreen FS, Inc. and pre-schedule tank wagon delivery.
